Thank you for your interest in the *NASW (Westchester) Whitney M. Young Stipend for Social Action and Change*. The criteria for the \$500 stipend/scholarship are as follows:

- ♦ Applicant must be a **Westchester County resident**; OR, applicant must be **enrolled in a Westchester social work program** and must have made a **significant social contribution** to the Westchester community.
- ♦ BSW applicants must be currently enrolled in a CSWE undergraduate program, in the Junior or Senior year;
- ♦ MSW applicants must be currently enrolled in a CSWE graduate School of Social Work;
- ♦ Applicant must have demonstrated commitment to social action/change;
- ♦ Applicant must maintain standards of social work values and excellence.

To complete your application, please include the following:

1. Completed **Award Nomination** form;
2. A **letter** from you stating your personal merits, professional ideals, and commitment to social action/change (reflecting the legacy of Whitney M. Young, Jr.);
3. **Two letters of recommendation** – one from your faculty advisor; and, one from a field or employment supervisor.

Deadline for receiving applications is Monday, **March 26, 2012**.

The award will be presented during the **Thirty-fourth Annual Whitney M. Young, Jr., Memorial Symposium**, April 2012.

The National Association of Social Workers, NY State Chapter – Westchester Division has been honoring Whitney M. Young, Jr., for the past thirty-four years. During our 2012 *Whitney M. Young, Jr., Memorial Symposium* in April, we will offer two \$500 stipends/scholarships to BSW and MSW students.

Individual students may apply for the award, or be nominated by faculty. The student must be currently enrolled in a CSWE School of Social Work: MSW candidates in a graduate school of social work; BSW candidates in their Junior or Senior year. The applicant must either be a **resident of Westchester County, OR**, must be **enrolled in a Westchester social work program** and must have made a **significant social contribution** to the Westchester community. She/he must have supporting material from a **faculty advisor** and a **field AND/OR employment supervisor**. The individual needs to have demonstrated a commitment to social action and change, and to the standards and values of the social work profession. This should be reflected in a letter of application from the nominee.

The focus is to create “a living memory” of Whitney M. Young, Jr., within the social work community. Please use the enclosed form to nominate students who deserve recognition. Feel free to distribute this form to faculty, students, agencies and field instructors. The deadline for nominations is **March 26, 2012**.
